**Subject:** 2025 VP Race Fuels C10 and Stay Frosty Order Form and Distribution Contacts

It is the responsibility of Teams and Riders to locate, procure and use VP Racing Fuel's C10 Unleaded Race Fuel. Use of VP C10 fuel is mandatory, use of VP Stay Frosty Coolant is *recommended*, as it is the Official Coolant of Progressive AFT.

**VP Racing Fuel will be pre-order only for the 2025 season.** The deadline to pre-order fuel will be **2 weeks prior to each event.**

Pre-orders can be made through the AFT marketplace site and drop-shipped to each event.
